## **Conference & Training**

As you will be aware, the next PMG conference has been further postponed to July 2022, and we have been able to strike a favourable deal with Telford International Centre to hold the 2023 and 2024 conferences there too.

Following the success of the two webinars held at the end of 2020, PMG hosted three more webinars in 2021, including the one preceding the AGM today. Our thanks to all the presenters, and also to Joyjit Sarkar for his continued commitment and hard work on the webinars project; also to Nathan Robson for editing the webinar recordings as webcasts.

#### **Journal**

Once the decision was made in February 2021 to further postpone the PMG conference to July 2022, the PMG manager became furloughed for half the working week, making use of the Government's Coronavirus Job Retention Scheme. The Conference Collective team have continued to monitor for stand and delegate bookings, and will be back in full swing in March 2022.
