# **Update for 2013-2014**

## **National Training Event**

Most unexpectedly, our post-event debrief with the University of the West of England yielded the information that they would be unable to host the NTE in 2014. Disappointing and alarming as that was, the Executive Committee and NTE Committee (under the strong leadership of Jo McConnell) pulled together extraordinarily well, not only making alternative arrangements for this year in Cardiff, but also securing Leeds for 2015!

Both venues will ensure that we can continue to advance education, as well as spreading the travel burden for our members.

Jo has had a baptism of fire as NTE chairperson – however, her calm demeanour and practical approach, along with the dedicated assistance of the rest of her committee have meant things have progressed smoothly, despite the uncertainties at the beginning. We trust you enjoy their efforts.

#### **Event Co-ordinator**

Due to the success of our part-time temporary events post (previously held by Ffion Lane), we created a full-time events and marketing coordinator post, and welcomed Nick Hunt to PMG in February 2014. Nick has already proved invaluable to the management team and, once NTE is complete, his attention will turn to marketing activities, working more closely with the Publications and Marketing Committee. Please make Nick welcome when you see him at the registration desk.

## **PMG Office**

As many of you may be aware, PMG has operated for many years out of a shed (no, really) in Olwen's garden.

However, to facilitate PMG's growth, we have rented modest office premises in the centre of Exeter – which Olwen assures me are truly luxurious compared to the shed!

## Membership Fee and Journal Format

The Executive Committee's role is to maintain the long-term strategic view of PMG and, as such, has considered ways to modernise PMG, ensuring that we become more accessible and can continue to grow. We'll discuss this at the AGM, but the proposal is to remove our membership fee, and change the journal format to a regular online resource. We recognise that many people are paying mandatory professional subscriptions, plus we'd like to welcome service users to our membership. After all, what we do is ultimately about enhancing their lives, so it makes sense to have them part of the process. The journal has long since been a very time consuming and costly item to produce and, although a quality production, it is surprisingly little read.

This year we've also removed the book tokens (which were largely unused by NTE-goers) and, instead, have doubled the bursaries available for people to attend NTE. We look forward to hearing your opinions at the AGM.

## **Charitable Incorporated Organisation (CIO)**

Existing members should already be aware through our online poll, that PMG's Executive Committee has recommended the change of PMG's status from "Charity" to "CIO". However at the time of writing, there was not a big enough vote for a majority. We will finalise the vote at the AGM if a majority is not reached before then. Either way, we'll let you know the outcome.

## **Strategy and Policy**

Things have been relatively quiet on the political agenda, but Henry Lumley, Linda Marks and David Porter have continued to ensure that PMG's voice is heard at senior levels. A Wheelchair Summit was held in February 2014, with six themes identified for development. A review is scheduled for October 2014, and progress in this area will be reported by Henry at NTE.

## **Education and Training**

The Mary Massery tour was a resounding success (despite horrific weather) at the end of 2013, with 133 delegates attending in Edinburgh, London and Manchester. The Education and Training Committee are now working with the National Wheelchair Managers' Forum (NWMF) to match provision the competency training with framework document already completed by NWMF. #### **National External Advisor**

Linda Marks (who is also to become a proud Grandma in November) has decided to step down from her role as the first ever National External Advisor of PMG, at NTE. We are very grateful to Linda, who has provided support on all levels to PMG throughout her four year term. We wish her all the best, and hope that as she can now fully enjoy retirement and grand-parenting, leaving work a distant memory!

We are however, privileged and delighted to welcome Ros Ham into the role of National External Advisor, and look forward to working with her in the coming months and years.

#### **Finance**

Pam Harper, as PMG Treasurer, will present a finance report separately, but our financial affairs are healthy.

I am, however, delighted to report that the outstanding VAT issues from the 2010 International Conference have now been settled to the satisfaction of all parties concerned.

#### Constitution

Should the changes to membership fees and CIO status be ratified, there will need to be some minor changes to the constitution to reflect these. These will be notified to the Charity Commission and Office for Scottish Charity Regulator in due course.

PMG will, in time, also be registered as a Charity/CIO in Northern Ireland, but the regulator

has only just begun registration, and is prioritising NI charities first.

## **PMG Administration**

Olwen Ellis, our administrative manager, continues to work as PMG's only permanent employee. Her contract was renewed this year, and is likely to be made full-time and permanent in August to streamline the general and NTE components of her role. We hope that the coordinator post will also be made permanent, so that PMG can continue to flourish with consistent management.

We once again thank Barend ter Haar and BES Rehab, who continue to provide the payroll facilities for PMG.

## **Publications and Marketing**

Things never stand still for long in the world of Publications and Marketing, and so once again we are faced with updating the website in the next year. This is because the behind-the-scenes framework holding it up is now obsolete, meaning bug fixes or additions are time-consuming and costly. This update at the "back-end" may not be overtly visible to users, but will ensure the functionality is secured for the next few years.

Iain McConnell, who provides our valued IT support, is currently drawing up the specification with James Foy so that quotes can be obtained.

#### Research

The research team continues to support applications for funding, and there are 14 completed studies (3 being presented at NTE), 4 currently on-going and 2 new applications so far this year.

#### **Commissioned Research**

Last year at NTE, we heard from John Warrington about the Department of Health's difficulties in gaining user views of wheelchair services, so we decided to find out for ourselves. Jo Goodship is leading this consumer view scoping exercise and will present the findings at NTE.

## **Executive Committee changes**

Quite a few changes to the membership of the Executive Committee this year, but a solid core of experience still remains.

I wish to thank all those who are departing and welcome the new faces.
