Position Status of Occupational Therapy in India

Occupational therapy is a skilled health care profession concerned with promoting health and attaining maximum level of functioning of people across all age groups including infants, children, adolescents, adults, and the elderly with neurological, developmental, orthopaedic, cognitive, psychiatric & behavioural problems by engaging them in purposeful & curative tasks based on their interests & potentials.

In simpler terms, an occupational therapist tries to help a patient improve the quality of his/her life. The aim is to make the individual integrate into the community and be productive in their life roles. The caseload of occupational therapists is dominated by paediatric cases including cerebral palsy, autism, learning disabilities, behavioural and emotional problems. And in adults, the common conditions are paralysis, hand, head and spinal cord injuries and other orthopaedic, neurological and psychiatric conditions.

Occupational therapy is a major emerging healthcare profession in India and the rest of the world. A large part of India's population can benefit from OT. Findings of the National sample survey organization carried out in 1991 suggest that 9% rural and 7%urban households in India have at least one disabled person (the average household size is 5.8 people). It is also a fact that only 1% of the population living in rural areas has access to some kind of rehabilitation service. This signifies the need for occupational therapists and the challenging role they have, both in urban and rural settings.

Children with disabilities are less likely to be in school, disabled adults are more likely to be unemployed, and families with a disabled member are often worse off than average. With better education and more access to jobs, people with disabilities can become an integral part of society, as well as help generate higher economic growth that will benefit the country as a whole. Occupational therapists play a crucial part in the Government's drives to reduce the numbers of people living with disabilities and help them participate in meaningful productive life – productive life provides them with an income and also adds value to their lives.

Occupational Therapy (OT) is being practiced in India for more than five decades. All India Occupational Therapists' Association (AIOTA) has been governing the education, practice & licensing of occupational therapy in India, since 1952. Unfortunately this potential, vibrant, noble profession doesn't have enough publicity as it deserves across the country.
